

## Directions For Use

### Hygienic Hand Disinfection

- Apply sufficient product to ensure complete coverage of the hands.
- Maintain coverage for 30 seconds, rub thoroughly until dry.

### Surgical Hand Disinfection

- Hands must be free from visible soil and thoroughly dry before commencing the surgical hand rub..
- Surgical hand disinfection is achieved by rubbing undiluted product onto both hands as necessary to keep wet for 120 seconds.
- At completion of rub allow hands to air dry thoroughly before donning sterile gloves.
